All individuals or families in crisis seeking assistance meet with a Catholic Charities representative to conduct an initial needs assessment to determine the best course of action to assist the entire family unit. These service areas usually fall under the following service related categories: food, clothing, rent, shelter, utility assistance, as well as access to state and federal programs including: CAL Fresh (food stamp) enrollment and renewal assistance, reduced-fee DMV ID vouchers and enrollment in the PG&E Care program.

Senior Companion Program - The Senior Companion Program provides senior companions (volunteer age 55 and over) who provide assistance and companionship to seniors who have difficulty with their daily living tasks. Companions provide assistance to the elderly and allow them to continue living independently in their own homes instead of moving into institutional care. Eligible senior companions earn a small tax-free stipend to cover the cost of serving. They also receive reimbursement for transportation, an annual physical examination, and supplemental accident and liability coverage while they are serving.
